In recognition of this acknowledged risk of injury, I knowingly and voluntarily waive all right and/ or causes of action of any kind, including any and all claims of negligence arising as a result of such activity from which liability could accrue to Factory Street Studio, its officers, agents, employees, instructors, subsidiaries, parent corporations, and all affiliated entities (hereinafter collectively referred to as "Factory Street Studio.") I hereby agree to release Factory Street Studio and hold Factory Street Studio harmless of all liability, and hereby acknowledge that I knowingly and voluntarily assume full responsibility for all risks of physical injury arising out of active participation in dance on behalf of the participant.

I am aware that this is a release of liability and an acknowledgement of my voluntary and knowing assumption of the risk of injury. I have signed this document voluntarily and of my own free will in exchange for the privilege of participation.

The participant (if under 18) has the permission of myself, a legal guardian, to participate in Factory Street Studio events. I further release Factory Street Studio of all liabilities associated with my child's attendance at Factory Street Studio.

I also give Factory Street Studio permission to use my child's picture in or on any form of advertisement for Factory Street Studio or a Factory Street Studio affiliated event.
